Terms of Reference Information, Education & Campaign (IEC) Materials Consultant

Background

Iranti is implementing a four-years policy protection project for transgender and intersex people called Margins to Mainstream funded by Commonwealth. This project is aimed at;

- Influencing policy through strengthened relationships and collaborative engagements between Transgender & Intersex (T&I) communities, Civil Society, and Government in South Africa by creating policy action groups in the five identified provinces.
- Amplifying marginalized voices by the creation of online and offline reporting systems where T&I persons will report violations and tell their stories to promote understanding, improve accountability, and impact public opinion to advocate for increased protections through policy and implementation.

Scope of Work

Iranti seeks to appoint a consultant to produce creative and accessible IEC materials for the purpose of knowledge dissemination of transgender and intersex topics and themes, as well as Intersex Genital Mutilation (IGM) and Legal Gender Recognition (LGR), under the scope of the *Margins to Mainstream* Project. These Terms of Reference (TOR) are established for the purpose of engaging with the IEC developer as external collaborator responsible for producing the IEC materials. The consultant will work under direct supervision, in close co-operation and report to the intersex and Transgender Rights programmes officers.

The contracted person will be responsible for:

- Generating clear ideas and concepts for developing the IEC materials content
- Designing catchy, impactful creative graphic elements
- Develop ideas for how a campaign can be created using these elements
- Understanding project initiatives, strategic positioning, and target audience
- Ensuring that the materials are accessible to a broad audience (government departments, educational institutions, community organisations, everyday people)
- Cooperating with the rest of the creative team
- Delivery of the IEC materials.
- Taking work from concept to final execution within deadlines
- Managing and delegating responsibilities to other designers and provide directions
- Presenting drafts for feedback to the core team
- Presenting completed ideas to core team
- Submit final report on the implementation of the activity
